WHEREAS, Article VII (Powers and Duties of the Board of Directors Including Fiscal Matters), Section 1 (Powers)(e) of the Bylaws of Bay Pines of Santa Rosa County Homeowners Association, Inc. authorizes the Board of Directors to employ a manager, an independent contractor or such other employees as they deem necessary, and to prescribe their duties; and

WHEREAS, Article IV (Board of Directors), Section V (Action Taken Without a Meeting) of the Bylaws of Bay Pines of Santa Rosa County Homeowners Association, Inc. authorizes the Board of Directors to take any action in the absence of a meeting which they could take at a meeting by obtaining the written approval of all of the Directors as indicated by the response from each Director below;

NOW, THEREFORE BE IT RESOLVED that the Board of Directors for the Bay Pines of Santa Rosa County Homeowners Association, Inc. shall rent on a continual basis, or until no longer needed, one (1) small post office box for a cost of \$90 (ninety dollars) per year at the United States Post Office located at 100 Northcliff Drive, Gulf Breeze, Florida 32561 which will include two keys to be kept and maintained by the Secretary and the Treasurer of the Association; as adopted by the Board on 16 March 2017.



Customer Agreement for PO Box Service Enhancements

The Postal Service is offering the following new services for PO Box customers at this Post Office® location:

- · Street Addressing
- · Signature on File
- Real Mail Notification™ Service

A. Street Addressing Service for your PO Box

With this service, you will have the option of using the street address of this Post Office location for your mailing address in addition to your PO Box number. For example, if a Post Office is located on 500 Main Street and you have PO Box 59, your mail would be addressed 500 Main Street #59. You will also be able to use the street address to receive most packages and deliveries through private carriers, such as UPS and FedEx Both Street Addressed mail and PO Box addressed mail can now be delivered to your PO Box.

- Please note that you are limited to this address format, including both the # sign and your PO Box number. For
 example, you may not use "Suite" or "Apt." Mail you receive at your PO Box without using the correct address
 format may be returned to sender.
- You may not use the street address option as your physical residence or place of business in legal documents.
 Misuse of your street address in this manner may result in closing your PO Box and may be in violation of civil and criminal laws.
- 4. You may use this address only for items that can be delivered through the mail. For example, you may not use the street address to receive shipments of wine, other alcohol, items over 70 pounds or items prohibited by Postal Service policy (see Domestic Mail Manual (DMM) Section 601), even though private carriers can carry those items. Any such shipments will be refused or held for pickup by the private carrier. The DMM is available at http://pe.usps.com/.
- 5. If you close your PO Box, you must submit two Change of Address (COA) forms: one for the PO Box address and one for the street address. Both forms must be forwarded to the same delivery address. Mail for a PO Box with street addressing cannot be forwarded to two different addresses.
- 6. If you decide to discontinue street addressing, mail bearing the street address will be delivered to the PO Box without charge for an additional 90 days. The 90-day period is designed to give customers enough time to communicate their address change to their mailers. After the 90-day readjustment period, all mail addressed to the PO Box street-style address will be returned to sender as undeliverable as addressed.
- 7. Private carriers are not liable for loss or damage that occurs to Street Addressed packages after the item is accepted and not refused by the Postal Service. DMM regulations for uninsured packages will apply for all packages that are lost or damaged while in the possession of the Postal Service.

IOTE: Street Addressing is not available for Caller Service, Reserve Number, or Group E Box customers.

No-Fee PO Boxes: The PO Box customer or any other person listed on the PS Form 1093 may file an individual change of address order. Only the box customer may file a change of address order for an entire family.

All other PO Boxes: Only the box customer who signs the PS Form 1093 may file change of address orders. Forwarding of mail for other persons receiving mail at the box is the responsibility of the box customer. To Ship Parkages ONLY to PO

PO BOX KEYS

Two keys are issued for key-type PO Boxes. An access code is provided for combination lock-type PO Boxes. At most locations, a refundable deposit is required for each key. If needed, you can obtain additional keys (and pay the applicable fee and deposit). Whenever your box service terminates, return all keys to the Postal Service for a refund of the deposit. Customers must not duplicate PO Box keys.

PO BOX REFUNDS

Once you have begun using your PO Box, you may request a refund at the Post Office where your box is located. Fees are refunded as follows:

3-Month Payments (automatic renewal required):

No refunds

6-Month Payments:

Within the first 3 months $-\frac{1}{2}$ the fee paid After 3 months - no refunds

12-Month Payments:

Within the first 3 months $-\frac{3}{4}$ the fee paid Within the first 6 months $-\frac{1}{2}$ the fee paid Within the first 9 months $-\frac{1}{4}$ the fee paid After 9 months - no refunds

BOX SERVICE ADDRESS

We deliver to your PO Box address as printed on your mail, so be sure to provide correct and current address information to your correspondents.

Your PO Box number should appear on a separate line, followed by the Post Office's city, state, and ZIP+4[®]. When we assign your box number, we will provide the corresponding ZIP+4 code.
